DINING ROOM OBLIGATIONS:

For 2021, members must spend \$100.00 Family / \$80.00 Individual in April / May & Sept. / Oct. - exclusive of Tax and Tip.

For 2021, members must spend \$120.00 Family / \$96.00 Individual each month of June, July, and August - exclusive of Tax and Tip

THERE ARE SEVERAL PAYMENT OPTIONS:

1. Payment in Full.

- If paid by 1-15-2021, you will receive 3 FREE 18 hole Rounds of Golf for guests.
- These expire 10-31-2021. Please see General Manager to attain guest passes.

2. 20% (\$487.81 Family, \$389.65 Individual & Family 40/75, \$310.58 Individual 40/75)

- First installment (20%) to be paid by 1-31-2020, remaining balance due by 3-31-2020.

3. Installment plan 20% over 5 months: Jan 1, Feb 1, Mar 1, Apr 1, May 1

- \$487.81 / month Family
- \$389.65 / month Individual & Family 40/75
- \$310.58 / month Individual 40/75

NOTE: 1st payment must be received before January 1, 2021 to qualify for the Installment Plan. Other payments must be received before the 1st of each subsequent month.

ANY BALANCES DUE AS OF 4/1/2021 ARE SUBJECT TO A FINANCE CHARGE OF 1.5% PER MONTH (ANNUAL RATE OF 18%)

PRIVATE CART TRAIL FEES (To be billed separately)

1. Gas Carts: \$700.00 + Tax
2. Electric Carts: \$730.00 + Tax

MEMBERSHIP EQUITY ACQUISITION COSTS (Part 1)

- \$1000.00 + \$60.00 (tax) = \$1060.00 (50% refundable)

This can be paid in 2 (two) installment:

- \$530.00 on acceptance & \$530.00 the following year
- You will attain voting privileges when membership certificate is paid in full.

MEMBERSHIP EQUITY ACQUISITION COSTS (Part 2)

- \$1000.00 + \$60.00 (Tax) = \$1060.00 (100% refundable)

Payment Options:

1. Pay in full your 3rd Year \$1000.00 + \$60.00 (tax) = \$1060.00
2. Pay in 4 installments:
 - \$250.00 + \$15.00 (tax) = \$265.00 per year over 4 years
